# **About this Easy Read**



This Easy Read is a **consent note** about how your information will be used if you **register** for our Disability Support Services **consultation** workshops.



Giving **consent** means you agree to something.



A **consent note** tells you what you are agreeing to.



You can find out more about this consent note on **page 6**.

**Register** means to say you want to do something.







- bring people together in a group
- talk to people about something important
- ask people questions.



In this document **consultation workshops** will be called **workshops**.

### What is a consent note?



This consent note will tell you how your information will be used if you are part of our workshops.



You do not have to be part of these workshops if you do not want to.




If you register to be part of the workshops you **consent** to your information being:

- collected
- shared.



You can choose to stop giving consent at any time.











If you stop giving consent before a workshop has been held:

- we will delete all your information
- you will not go to any workshops.

If you stop giving consent after a workshop has been held:

- we will delete your contact information
- we will **not** be able to delete anything you have told us as part of the workshops
- you will not go to any more workshops.

# What are the workshops for?



The workshops are for you to tell us what you think about:



- how we can make it easier for people to understand our:
  - assessment processes
  - allocation processes



- who can get flexible funding
- changes to how flexible funding can be used.



**Assessment processes** means how we choose who can get flexible funding.



Allocation processes are how we decide how much flexible funding someone gets.



**Flexible funding** means disability funding that can be used for a lot of different things.



What you tell us as part of these workshops will support us to:



- give the Government information about how we could have better:
  - assessment processes
  - o allocation processes



 give the Government the information they need to make choices about changes to flexible funding.

### Your information



We need to get some information about you if you register for the workshops.



This part of the Easy Read document will tell you about:

- what information we collect
- what we use the information for
- how we protect your information.

### **Registration information**

All is for All is doing the registrations for these workshops.



Some information about you will be collected so that you can take part in the workshops.



This information will be used for:

- planning the workshops
- making sure things are working well
- writing reports.



The information that All is for All will share with Disability Support
Services from your registration form will be:

- the workshops you have chosen
- if you are bringing a support person
- your access needs.











Other information that All is for All will share with Disability Support
Services from your registration form will be:

- comments you have written on the form
- if you need a New Zealand Sign Language / NZSL interpreter
- things you may have chosen to tell us about you like:
  - o what your disability is
  - how you are connected to the disabled community
  - o your **ethnicity.**







### Ethnicity means your:

- race like:
  - o Māori
  - o Samoan
  - o New Zealand European
- background like whether you:
  - were born in Aotearoa New Zealand
  - moved to Aotearoa New
     Zealand from another
     country.



We will **not** share personally identifiable information with DSS.



Personally identifiable information is information that could tell someone who you are like your:





 contact details like your phone number.





Personally identifiable information will be deleted when the workshops finish on **24 March 2025**.



### **Workshop information**



The things you say in workshops will not be:

- audio recorded
- video recorded.



We will write some notes about what you think.



We will remove any information that could tell someone who you are before we use these notes.



We may use **demographic information** to see if there are any patterns.





**Demographic information** means information about what groups you are part of like:

- what part of New Zealand you live in
- your age group.



No personally identifiable information will be connected to your demographic information.



Only **authorised staff** working on this project will have access to the information you give us.







### Authorised staff are people who:

- work for:
  - o DSS
  - Ministry of Social Development
  - o All is for All
- are working on this project
- are allowed to look at the information we collect.

# **Privacy in workshops**



We will do everything we can to make sure that no one can tell who you are in our:



- reports
- workshop notes.



But there will be other people who are part of the workshop who will:

- see what you share
- hear what you share.



We will explain that things shared in the workshops should not be talked about outside the workshops.



We cannot promise that the other people who are part of the workshop will not talk with other people about what is shared.


#### Your consent

- understand what you are agreeing to.


